#### LETTER FROM OUR PRESIDENT

In a recent Board to Board communication from AAUW California, they note that AAUW is 140 years old, and AAUW California is 100 years old. The Auburn Branch was organized in 1948 and chartered in 1949 - our Branch will be 73 in 2022.

In 1949, the Auburn Branch established a fifty-dollar annual grant-in-aid to a freshman girl attending Placer College. (Placer College was the precursor to Sierra College.) We continue the tradition today. Our scholarships have grown from one \$50 scholarship to up to eight freshmen, two transfer, and one re-entry. The \$50 has grown to \$1,000 each.

I can't think of a better way to advance women's qualifications and leadership skills.



#### WOMEN IN LEADERSHIP— A FIFTH IN OUR SERIES

#### Sheryl Petersen

Sheryl is currently the President of Auburn Sunset Rotary, Board Member of the Auburn Senior Center, and former Auburn AAUW President 2012-2015.

Born in San Francisco and raised in Pacifica, Sheryl graduated from San Jose State in 1977, and in the next 27 years served as an Administrator, Teacher, Coach, and wearer of many hats at the Athenian School in Danville. In her last 14 years as Director of Special Programs, she developed income generating programs, while hiring, training, and supervising a seasonal staff of 85 employees. She received her MS in Education Leadership in 1999 from Cal State East Bay.

After moving to Foresthill in 2004 to be closer to aging parents, Sheryl then served as the Recreation Services Manager for Auburn Parks and recreation District (2005-2019) overseeing a seasonal volunteer and paid staff of 100+. During her tenure some accomplishments included: creating new community events and programs, offering innovative classes, developing innovative activities, as well as instituting a college internship program.

Following retirement in 2019, she is currently employed by Salarno Besselman LLC and Crime Victims United working in support of fundraising events, grant writing, daily operations, community outreach and special programs.

Q: What is one lesson learned that's unique to being a woman leader?

An important lesson Sheryl has learned as a leader is that we need to pay special attention to empowering young women through education and experiences-supporting them to trust their intuitions and decisions, providing a gentle landing space for their outcomes and a realistic evaluation of their experiences coupled with next best step strategies.



Q: What advice would you give aspiring female executives?

Sheryl is candid when advising her younger executive self: "grab your sister's hand and offer her that step up; mentor and support her; provide her new opportunities for growth; open doors for networking with others; and most importantly, celebrate your sister's successes."

Q: Name a woman who has inspired you.

Sheryl- recognizes the benefit of being mentored, "I have been most fortunate to have several important women who have inspired me through my career; most notably Eleanor Dase, former Head of the Athenian School. Eleanor influenced my leadership style, teaching me: the importance of listening more than talking in relationships; the value of being prepared at all times; the significance of acknowledging the value of every voice at the table; the celebration of the success of others is paramount; always respect the time of others; and know when and how to have fun."

### WELCOME OUR NEW MEMBER CAROL ROEDDER



Carol Roedder is one of the newest members of AAUW. She started her life in Compton, California, and moved to the San Joaquin Valley at the age of ten. Her family struggled financially, and she was told that she would not be able to go to college.

Somehow, her mother talked to the financial officer at UC Berkeley, who told her that any student who could get in and stay in on merit would not be turned away. As a result of that conversation, Carol applied on June 1 and was accepted on June 6 – five days later! She graduated with a major in French and a minor in music, getting her teaching credential after that.

She spent two years studying in France – one at the University of Bordeaux and the other at the Sorbonne – during what where some of that country's largest political upheavals. As a result, her classes were frequently cancelled, leaving time to make new friends and travel. She still keeps in touch with many of these friends today.

Carol says that when she graduated from high school, she had an "Ah ha!" moment during "Pomp and Circumstance" and knew without any doubt that she always wanted to be in a school. She loved the students and the atmosphere, so she became a teacher and has never looked back.

When her two daughters were young, she became fascinated with the process of growth in small children, so she pursued a masters degree in education with a specialization in Montessori learning. Later, when teaching teenagers, she found she could apply many of Dr. Montessori's ideas to the middle school classroom. At one point she moved into the principal's chair, but after a few years decided she was a teacher at heart.

After fifty years in the Bay Area, Carol moved to Auburn to be near one of her children, Alexandra, who plays cello in both the Auburn and Folsom Lake symphonies. Her other daughter, who lives in Los Angeles with her husband and two children, plays the viola.

Carol has played the violin since age 10, and now also plays with both the Auburn and Folsom Lake symphonies with Alexandra. Her husband was a pianist, and the family would play quartets together when there was time.

Carol enjoys hiking and cycling and a few years back did some multi-day cycling tours of 500 miles or more. She tries to hike a few miles along the canals or in the canyon each day.



## Q and A with School Board Member Julann Brown



**Editor's Note:** As a former journalist, and later as a teacher, I attended my fair number of school board meetings. These comments from AAUW member Julann Brown are by far the most concise, philosophical, and informative that I have ever experienced.



**Q:** How are School Boards organized, and what does a School Board Member do?

School Boards are usually 3, 5, or 7 members. School board members are locally elected public officials entrusted with governing a community's public schools. The responsibilities of a school board are numerous, the most central of which is ensuring that a long-term vision is established for the school system. The vision reflects the consensus of the entire board, the superintendent, staff and the community as to what the students need in order to achieve their highest potential.

School boards also establish an effective and efficient structure for the school district. This starts with the hiring of the superintendent and setting policy for hiring other personnel. A school board sets direction and policies around curriculum, prioritizing the allocation of resources, adopting the budget, and overseeing facilities. The school board determines the "WHAT," and the Superintendent and staff determines the "HOW."

A school board governs by consensus; no single board member has more authority than any other. Regardless of members' individual beliefs - the school boards speak as one voice once a decision has been made. As community representative, the board is accountable to the public for the performance and efficiency of the community schools. As the only elected officials chosen solely to represent the interests of schoolchildren, board members also have the unique responsibility to speak out on behalf of those children.

#### **Q:** How did you get interested in becoming a School Board Member?

It all started with my involvement in my sons' school, Alta Vista. I volunteered as an Art Docent and served on the PTC (Parent Teacher Club). That experience led to serving on district-wide budget committees and advocating and campaigning for a number of parcel tax initiatives (unfortunately, none met the  $\frac{2}{3}$  threshold).

I discovered that in order to really influence educational policy and advocate for both reform and more funding, I needed to serve at a higher level. Once both of my sons moved out of the Auburn Union School District (K-8 district) and on to high school, I threw my hat in the ring for an open seat in 2014.

#### Q: What is a typical meeting like?

School boards are required to hold their meetings in public and must allow for public comment. It is important to emphasize that a school board meeting is not a meeting of the public, but rather a meeting to conduct the district's business in public.

AUSD holds monthly regular meetings and a number of special board meetings or workshops. Our regular monthly meetings first start with a closed session, which is not accessible to the public due to the confidential nature of what is discussed (personnel, litigation, student discipline). The agenda and supporting documentation is posted and publicly available at least 48 hours in advance.

A typical meeting will consist of a special presentation featuring one of our five schools. We open up to public comment for items not listed on the agenda, which are usually limited to 20 minutes. We then have a Superintendent update, followed by reports of individual board members. After that, the agenda is divided up into a few sections.

- Consent Agenda: addresses routine operational matters that need board approval but not discussion or debate.
- **Actions items**: matters requiring approval of staff recommendations that merit discussion or debate.
- **Discussion items:** matters that may lead to Board direction for the Superintendent or future action by the Board

**Board Governance :** review and revisions of Board policies and protocols

#### **Q:** How do you go about running for office?

You need to file your Declaration of Candidacy with your county elections office. The site <a href="https://www.placercountyelections.gov">www.placercountyelections.gov</a> is a great resource! You will find a listing of open seats throughout the county and state. There are tutorials and workshops once the 2022 election cycle approaches. Learn as much as possible about the office you have chosen to pursue by speaking to current office holders and attending meetings.

As far as campaigning, the best thing to do is be visible in the community and be engaged with local service clubs.

#### **Q:** What are the rewards of running for office?

The biggest reward is the opportunity to share your business and life experience to benefit your community. You can represent different groups in the community and ensure that others have a voice in making policy decisions that have a direct impact on your community.

"I believe that the foundation of a thriving community is an equitable education of all our children. For me, personally, the reward is knowing that what I do is helping build that strong foundation."

#### Q: What is the best way that our community can support our schools?

We have a community of students and staff who are trying to recover from the trauma of the COVID shutdowns of 2020 and 2021. Staffing shortages are currently crippling school districts. One of the best ways to support that recovery is by offering your time. If you can, volunteer or apply for some of the many job openings.

#### **Q:** What frustrations do you have?

School Board trustee is a nonpartisan office. Unfortunately, school boards and public education are currently at the center of partisan politics. Many school boards have been inundated with combative and radical factions, focused on grievance and false controversies. School boards need to hear from the community members that support good governance that maintains a focus on providing a safe and vibrant learning environment for all of our children.

"There is such important work to be done and so many opportunities to address the many inequities in our educational, health and justice systems that COVID has exacerbated. Unfortunately the noise of partisan politics is getting in the way from the real work that needs to happen to heal our community and nation."
